#### **COMMUNICATIONS AND ANNOUNCEMENTS:**

Good Friday – Town Hall Staff is observing Good Friday on Friday, April 10, 2020 in Observance of Good Friday. One half of the rotating crew of the Highway Department will be Observing Good Friday on Friday, April 10, 2020, with the other half Observing Good Friday on Monday, April 13, 2020. There was some discussion about the Town being reimbursed for payroll expenses through government programs.

#### **OFFICIALS AND COMMITTEE REPORTS:**

<u>Planning Board</u> – The next regularly scheduled meeting is a joint meeting with the Zoning Board of Appeals to be held on Monday, April 13, 2020 at 6:30 p.m. Supervisor Rounds will reach out to Chairperson Chris Streno requesting that the members of the Planning Board conduct the meeting via Zoom. An educational session will be conducted by Town Attorney Pope regarding the Coronavirus, and how to have a meeting with a resident, if needed.

Zoning Board of Appeals – The next regularly scheduled meeting is a joint meeting with the Planning Board to be held on Monday, April 13, 2020 at 6:30 p.m. Supervisor Rounds will be reaching out to Chairperson Gerardo Tagliaferri requesting that the members of the Zoning Board of Appeals conduct the meeting via Zoom. An educational session will be conducted by Town Attorney Pope regarding the Coronavirus, and how to have a meeting with a resident, if needed.

<u>Youth Commission</u> – The youth programs have been put on hold. Residents who have paid the registration fee for youth programs will be reimbursed by the Town if they so desire. There is hope that there will be a short season at some point.

<u>Code Enforcement/Building & Grounds</u> – Mr. Pappas is continuing to perform his job duties in both capacities. Zach Soboleski and Tim Hawley have been picking up trash on the Town roads, including Hawleyton Road and Park Ave. as the Broome County inmates will not be picking up trash on roads.

There was discussion concerning the LED replacement of the Town's street lights by NYSEG. The Town's most recent NYSEG bill reflected a reduction of \$1,200 due to the agreement to have the installation of the LED street lights performed by NYSEG.

<u>Highway Department</u> – The Highway Department will be returning to full staff on April 20, 2020. One hundred percent of the Pave New York and Extreme Weather funding is in the NYS budget at 100%, but the Town may only see 25% of the monies. CHIPS money is also in the NYS budget for 2020.

TOB Volunteer Fire Co. – There was no report.

<u>Coronavirus - Update</u> – A moment of silence was held to think about what our country is going through, and for the 12,000 people that have died.

# RECOMMENDED PROCEDURE AND EXECUTIVE ORDER 202.1 COMPLIANCE LANGUAGE

When opening a virtual meeting via ZOOM/teleconference, the Supervisor should follow these steps:

- 2. Have Clerk call the role of Board members; each member must orally state that he/she is present. Confirm quorum.
- 3. Read the following language into the record:

I Supervisor, Elizabeth Rounds, have confirmed with Counsel that this meeting is being held in compliance with Executive Order 202.1, issued by Governor Andrew M. Cuomo on March 12, 2020. The Executive Order suspends Article 7 of the Public Officers Law to the extent necessary to permit any public body to meet and take any action authorized by law without permitting in public in-person access to meetings and authorizing such meetings to be held remotely by conference call or similar service.

This meeting is being held remotely via ZOOM virtual meeting software. The public has the ability to view or listen to this meeting live via the ZOOM app, web browser and/or by telephone. This meeting is being recorded, and will be transcribed at a later date.

# SECTION 504 RESOLUTION Town of Binghamton

**WHEREAS**, Section 504 of the Rehabilitation Act of 1973 prohibits discrimination on the basis of disability in programs and activities conducted by the U.S. Department of Housing and Urban Development (HUD) or by grantees that receive financial assistance from HUD, and

WHEREAS, Part 8 of Title 24 of the Code of Federal Regulations (24 CFR) requires adoption of grievance procedures to address complaints of those who feel they may have been discriminated against on the basis of disability and also requires the provision of notice of said grievance procedures, and

WHEREAS, it is the policy of the Town of Binghamton not to discriminate against any individual, person or group on the basis of disability and the intent of the Town to address any complaints that may arise pursuant to Section 504,

NOW, THEREFORE, BE IT RESOLVED that the Town of Binghamton does hereby adopt by resolution internal grievance procedures (the "Procedure") providing for the prompt and equitable resolution of complaints alleging any action prohibited by Section 504 of the Rehabilitation Act of 1973 of the U.S. Department of Health and Human Services regulations implementing the Act, and

**BE IT FURTHER RESOLVED**, that the Town of Binghamton does hereby designate Councilperson Michael Bensley as the Grievance Coordinator who shall be responsible for receiving and addressing complaints pursuant to the Procedure adopted hereby and attached hereto, and

BE IT FINALLY RESOLVED, that the Town of Binghamton will place its employee, the public, and potential beneficiaries of certain federal public programs on notice by undertaking certain actions that will include, but may not be limited to (1) providing a copy of the grievance procedure to its employees, (2) putting the public on notice by placing a notice in the Town's official newspaper subsequent to adoption of this Procedure, (3) placing a copy of the Procedure on the Town Clerk's sign board in the lobby of the Town of Binghamton Town Hall and copies on the table in the lobby of the Town of Binghamton Town Hall, 279 Park Ave., Binghamton, New York for review and dissemination, and (4) adding language to federal program brochures to insure all potential program beneficiaries are aware of the Town's adopted grievance procedures.
