Hello, everyone. It seems as if all of our lives have been turned upside down as a result of a virus named COVID-19. The first pandemic since 1918 has possibly changed our lives forever. There is no doubt our Town, County, and State will eventually reopen, and we will start living our lives again but things may be different. With that being said, I thought I would focus on a few positive things that are currently happening in our Town.

I hope all of you are aware of the Community Development Block Grant (CDBG) the Town received last year. We were very lucky with a mild winter this year. It was nice to even experience a few spring-like days! Fortunately for us, we were able to start spring cleanup earlier than usual, so we were actually ahead of the game when the unexpected Coronavirus hit. We're now looking ahead to our brush and branch pickup (see below), getting back to filling in those pesky potholes, and soon we'll be sweeping the roads. As the season continues, we'll move on to ditch cleaning and paving throughout the summer.

We have some projects scheduled for late spring/early summer. Cynthia Drive and Laurie Brook Drive will be milled and repaved this year. We will also be doing sanitary pipe lining on East and West Hamton Rd. to Moore Avenue. NYSEG has also informed us that they will be continuing their work throughout the town replacing some gas services on Dogwood Drive and St. Clair Road.

Some of you may already know that winter can wreak havoc on your driveways and culvert pipes. If you notice that you're in need of a new pipe, the Town will install it at no cost to you, but you're responsible for the cost of the pipe. If you need a new culvert pipe, just give us a call at 669-4323, and we'll measure it and get a price for you.


SPRING TREE BRANCH & BRUSH PICKUP - JUNE 1 to JUNE 12, 2020

The Town of Binghamton Highway Dept. will be picking up branches beginning on Monday, June 1 and ending on Friday, June 12.

This pickup is for TREE BRANCHES ONLY. No cuttings from any kind of bush. Please call the Highway Dept. at 669-4323 to have your name placed on our list. Due to the overwhelming response to this service, you will not be given a specific time or day when your brush will be picked up.

In addition, there are certain guidelines to be followed:

- 1. Tree branches from your yard only;
- 2. Put branches neatly along the curb/roadside in front of your home;
- 3. Please place the large end of the branch towards the road, and leave the branches as long as possible;
- 4. No brush from clearing your lot;
- 5. No brush from contractors or landscapers. (This means if you hire someone to maintain your lawn, they need to dispose of the debris; we will not take it.)
- 6. Large piles must be approved.





The Water/Sewer Billing Schedule for 2020 is as follows: (these are approximate mailing dates)

May 1, 2020 (3rd billing); due in early June August 1, 2020(4th billing); due in early September

WHAT IS "TAXABLE STATUS DATE"? Joseph Cook, Assessor



Here's just a bit of information about the tax year. The tax year, for assessment purposes, is a fiscal year that begins July 1 and runs through the following June 30. Each year the Assessor's Office establishes a new tentative tax roll on May 1 that goes into effect on July 1.

The assessment that is shown on that new July 1 tax roll reflects the status of the property on March 1, which is called "taxable status date". This becomes important information for you if you are building a new house, constructing an addition to your existing house, demolishing a building, etc.

As an example, if your home is 50% complete as of March 1, the July 1 tax roll reflects 50% of the finished value of the home. The assessment then does not change again until the following tax year, because once the July 1 tax roll becomes effective, it is frozen by law and cannot change (up or down).

Property Maintenance issues are always at the top of my list in the spring because once winter is over and the snow has melted, junk is on view for the world to see. If you receive a violation letter from this office, you need to respond immediately. I'm always willing to work with the property owner as long as corrective action is taken within a reasonable amount of time. If the property owner doesn't respond to my letter by calling my office and speaking with me, my only option is to turn the matter over to

Town Court. If you're unsure as to what is or is not acceptable, the Town Code is available on our website (under "Building Codes & Permits"). It's a great way to familiarize yourself with what is and what is not allowed in our Town.

I'm assuming you've already read that the Town is once again participating in "Municipal Cleanup Days". This is a great opportunity to get rid of unwanted items that have been stored in your yard, garage, house, or basement. I highly encourage all of you to take advantage of this free service and clean up around your property. Where else can you get rid of your junk for *FREE*?

Finally, I'd like to remind residents of the importance of getting a building permit. Some projects require a permit and some don't. It's always a good idea to call my office before beginning any new building project. My phone is listed above. Thanks, everyone.

I'm sure many of you have been spending a lot more time with your pets because of the Coronavirus. I know I have been. Hopefully, we'll be out of this long quarantine soon! Here are a few tips to keep your pets healthy and safe this spring:

- Check with your veterinarian to see what's recommended for Heartworm and Lyme Disease.
 Heartworm is transmitted by mosquitoes and Lyme Disease is transmitted by ticks; both can be fatal. Be sure to also ask your vet about all-natural flea and tick treatments.
- If you enjoy taking your dog for a ride in a car or truck, if at all possible, confine it in a crate or
 use a seat belt safety harness. Never allow your dog to ride in the back of a truck or hang its
 head out a window. Also, don't leave your dog confined in a car on a hot day. It can be a deadly
 mistake!
- Make sure you license your dog with the Town Clerk's office. ID tags should be kept on your dog's collar at all times and will assist me when I try to reunite you and your dog. The best ID's are license tags and microchips. Most veterinarians can chip your dog. Just ask the next time you take your dog for a check-up. Most importantly, if your dog gets loose, call me on my cell at 217-8857. There's nothing better than to be able to reunite a pet with its owner. With spring now upon us, conditions for wildfires have become heightened and residential brush burning is prohibited through May 14 across New York State. While many people associate wildfires with the western part of the United States, spring weather and the potential for dry conditions increases the risk for wildfires. Garbage burning and leaf burning are always prohibited. Violators of the state's open burning regulation are

NEWS FROM OUR COUNTY LEGISLATOR, KELLY WILDONER



Now that 2020 is well under way, I wanted to take a moment to update the residents of the Town of Binghamton on some exciting things the County Legislature has been doing.

The Legislature continues to look out for County taxpayers. In case you missed it, last fall we unanimously approved the 2020 County Budget with a 1% tax cut for County residents. We were able to double the proposed tax cut while improving vital services that taxpayers rely on. Even more good news, with this last budget we were able to

continue cutting the County's short-term borrowing. This has been a major factor when receiving our credit rating and helps us get more favorable finance terms so that we can keep your taxes in check! This is the second tax cut in a row, and we're very proud to be able to continue providing results with common sense budgeting, keen financial oversight, and advocating for lower taxes.

The Legislature continues fighting against state mandates that affect our residents' wallets. We very recently approved a resolution urging New York State to increase the County share of DMV revenue for services that are provided by our local Department of Motor Vehicles. It is unfair that our local DMV and taxpayers are forced to carry the burden of providing these services while the State takes the large portion of the revenue. That's why I was proud to support this effort!

In January, I was very proud to have the opportunity to recognize the Susquehanna Valley Senior High School football team at the Legislature's monthly regular session for winning the 2019 New York State Class C Championship! This team has had back-to-back undefeated seasons and has taken home the title two years in a row. Being able to meet these impressive student athletes and to see the potential of our community's youth is one of my favorite parts of the job. I couldn't have been prouder to congratulate them on their achievements.

The County is working hard to keep our residents safe from the COVID-19 threat! Everyone in our nation and our community is being affected by the health and safety risks of the Coronavirus. Nothing is more important than the welfare of our residents, and the Legislature is working hard with Federal, State, and local officials to do everything we can for your protection. In the coming weeks, the County will be securing federal funding to help alleviate the emergency costs of the pandemic. Also, even though schools have closed to ensure the safety of our students, we've partnered with Broome-Tioga BOCES to set up meal pick-up sites where lunches can be collected for youth in need. We're also using our Transit buses to make stops at several of these sites to make them more accessible. Just recently, the federal government provided the County with 68,000 masks that are being distributed to the public at this very moment. Essential businesses can also contact the County Emergency Operations Center at 607-778-1183 for information on how to access masks to keep your employees safe. I also want to personally thank each of the private business owners that have opened their doors to help feed our community's youth in this time of need along with the thousands of healthcare professionals and first responders fighting on the front lines to protect us all. As a lifelong resident of Broome County, I've seen this community at its best and its worst. One of the reasons I love and admire our area is because, in the worst of times, we band together and help one another to come through to the other side better and stronger for it. I trust that, in the face of the current pandemic, we will come together as a community once again to overcome the trials ahead. Always remember, it's not what one person can do on their own, it's more about what everyone can achieve together.
