Happy New Year, everyone! I don't know about you, but I'm happy to put 2020 behind us and to begin a brand new year. We had so many crazy things happen last year including a 3 1/2 foot snow storm! Let's all hope 2021 can return us to a semblance of normalcy.

We continue to receive inquiries from residents about the **Community Development Block Grant (CDBG)** that was awarded in 2018 and provided Town funds to qualified, income-eligible homeowners to help with home improvement projects including roofing, insulation, siding, plumbing, heating, carpentry, windows, etc. We've hired Thoma Development Consultants of Cortland, once again, to prepare a new CDBG application. If we are awarded new funding, and if you had previously filled out an application and received approval but never received funding, you can assume you'll be at the top of the new list. All other residents interested in being placed on the waiting list should contact Thoma at (607) 753-1433 to request a pre-application. Thoma's hours are Monday through Friday from 8:30 a.m. until 4:30 p.m.

You'll notice a new feature in this edition called, "In the Spotlight". This new segment will promote individuals or small businesses that have accomplished great things. This thought came to me when Becky asked if she could write an article about Missy Chapman who recently had her book, "Distant Skies", published. NEW PROTOCOL FOR COVID: In the interest of keeping our residents safe, we will accept exemption applications in the following ways:

- By mail. Return to: Town of Binghamton Assessor, 279 Park Avenue, Binghamton, NY 13903
- Leave in the drop box located on the front of the Town Hall building
- Email to: <u>assessor@townofbinghamton.com</u>
- Fax to: (607) 772-6911

If you're unable to make the required copies for verification of income, you may mail your originals to us, and we'll return them after your application has been processed. We understand we are living in challenging times, and we'll do our best to work with you to make sure this process is as stress-free as possible. With all of that said, we hope your new year is off to a positive start! We have information at present that we hope you will find helpful:

THE GOVERNOR HAS CHANGED THE RENEWAL REQUIREMENT FOR THE SENIOR EXEMPTION (AGED) AND DISABILITY EXEMPTION. THIS MEANS YOU'LL RECEIVE THE SAME EXEMPT STATUS THAT YOU HAD IN 2020 WITHOUT FILING AN APPLICATION. The Governor has passed an Executive Order in response to the COVID-19 pandemic that permits the local municipalities to suspend the requirement for renewal applications to be filed for the 2021 assessment roll. In the interest of keeping our residents safe, the exemptions covered by the Executive Order for 2021 that waive the renewal requirements are:

- Partial Tax Exemption for Real Property of Senior Citizens (467)
- Partial Tax Exemption for Real Property of Persons with Disabilities and Limited Income (459-c)

Normally you would receive a renewal application to continue your coverage under one of these programs. This action will ensure that you will receive the same exempt status that you had on the 2020 assessment roll without filing the application. If the Assessor's Office receives any information that would lead to a change in your exemption status for either of these programs, you will be notified. Thank you.

We are currently in the exemption application period for the 2021 tax year. All exemption applications <u>MUST</u> be received each year between January 2nd and March 1st. If you plan to file for an exemption (Enhanced Star, Low-Income Senior, Veteran, Disability, etc.), now is the time. If New York State requires information, they will contact you directly, and you must reply promptly. The exemption deadline is Monday, March 1, 2021.

Enhanced "STAR" for Seniors: If your household income ("adjusted gross income" minus "taxable amount" of total IRA Distributions) falls between \$31,501 and **\$90,550 for 2019**, this is the school tax exemption for which you qualify.

Low Income Seniors: If your gross income for 2020 is **\$31,500 or below**, including Social Security, then you not only qualify for the Enhanced "STAR", but you are eligible for an additional exemption that may apply to the county, town, or school district, depending on your income level. This exemption is based upon a sliding scale.

Income Verification Program: If you're applying for the **Enhanced STAR exemption**, you <u>must</u> enroll in the Income Verification Program (IVP). You need only to enroll once, and you'll receive the exemption each year, as long as you're eligible. In the first year, your assessor will verify your eligibility based on the income information you provide. In the following years, NYS will verify your income eligibility. You will not need to reapply for the exemption or provide copies of your tax returns to your local assessor.



Already in the Income Verification Program? You don't need to take any action to continue receiving the Enhanced STAR exemption. The Tax Department will contact you if it needs additional information. If you are also receiving the low-income senior exemption, you will still need to annually reapply for that benefit with your assessor.

This information does not apply to new homeowners and first time STAR applicants. If you're a new homeowner or have never filed for the STAR exemption, you may now qualify for the "**STAR CREDIT**". You may register online at <u>www.tax.ny.gov/star</u> or by phone (weekdays from 8:30 a.m. to 4:30 p.m.) with New York State by calling (518) 457-2036. Local Assessors are no longer allowed to accept new STAR exemptions.

After dealing with the most historic, record-breaking snowstorm this area has ever seen, we'd like to take this opportunity to provide some important tips to help in dealing with future snowstorms:

- PLEASE DO NOT PARK ON THE STREETS OR IN DEAD-END AREAS WITH SIGNIFICANT SNOWFALLS. MANY OF OUR STREETS ARE VERY NARROW AS IT IS, AND WITH PARKED CARS, IT MAKES IT EXTREMELY DIFFICULT (SOMETIMES IMPOSSIBLE) TO PLOW THE ROADS AND TO REMOVE THE SNOW. WE HAVE A PARKING ORDINANCE FOR A REASON, AND RESIDENTS NEED TO ABIDE BY IT. YOU WILL BE TICKETED.
- Make sure your snow removal equipment is in good working order.
- Always carry a flashlight, blanket, snow scraper, and jumper cables in your vehicle.
- Remember to slow down and allow extra travel time.
- The news media will announce approaching storms and will keep you updated on closings, cancellations, and re-routings so please pay attention. It is important to remember that snow accumulations and road conditions can vary in our higher elevated areas. We will continue to do our best to keep the roads clear for travel.
- Try not to go out during or immediately after a storm. The less traffic on the roads means we can clear the roads more quickly and completely. Our crews have designated routes so you can be assured that someone will be around to clear your area. Please be patient.

HELPING YOU UNDERSTAND SNOW PLOWING PROTOCOLS

 We receive many calls each year asking us to pick up our plows when we come to your driveway. That is not something we do. Our main focus is to remove snow from the roads. With last month's historic snowfall, we had a substantial number of phone calls regarding driveways being blocked by the snow shoved by our plows. It is our responsibility to remove snow from the roads, not your driveway. It is the homeowner's responsibility to remove the snow from their

driveway. Please hire someone to remove the snow from your driveway if you are unable to. If you are a senior citizen, the *Office for the Aging* may be able to recommend someone to plow for you (for a price). You can reach the *Office for the Aging* at 778-2411. If you are able to shovel your driveway manually, be sure to shovel your snow to the right which is the same direction our plows push the snow. Finally, keep in mind that pushing snow into the road can create a hazardous condition. Please don't do it.

• There are times when your mailbox may be knocked over by our plows. If this happens, please call Nadine at the office, and we'll try to fix it as soon as possible. As always it is never our intention, but in hazardous conditions...it happens.


Your understanding and cooperation are an important part of our snow removal plan. We appreciate any help you can give us.

The COUNTY is solely responsible for COUNTY roads. If you are unsure which roads are County roads, they are: Brady Hill, Hawleyton, Murphy, Park Ave., Pierce Creek, Powers, and Saddlemire. If you have a complaint concerning the maintenance of any County road, please call 778-2228.

WATER/SEWER RATES TO INCREASE IN FEBRUARY — We'll be reading meters at the end of January, and new bills will be mailed out at the beginning of February. With that being said, you may have heard about the new rate increase that will be reflected on this bill and all future bills. Due to the continuous changes and costs of the Binghamton-Johnson City Joint Sewage Treatment Plant, we need to adjust our rates accordingly. When we compare what the Joint Sewage Treatment Plant bills us for, to what we bill and collect from our residents, we are in a shortfall and need to increase our water & sewer rates. Rates have not been increased since 2018, so it may seem more significant than usual. We appreciate your cooperation as we navigate through the upcoming water/sewer billing changes. THE TOWN IS NOT RESPONSIBLE FOR REPAIRS TO FROZEN WATER METERS AND PIPES — This is a friendly reminder that it is the homeowner's responsibility to maintain heat in and around the water meter and pipes to keep them from freezing. It's imperative that you make it a priority to keep your meter and pipes warm. A water break inside your home can cause considerable damage to your home and its contents, PLUS it will cost you \$450 to replace one of our water meters. Please call us if you have any questions.

It's telling you there is a problem! **Call 911 immediately, NO MATTER WHAT TIME IT IS!** These are life-saving devices and should not be ignored.

If you live near a fire hydrant, please do us a favor and shovel it out. This could save us a lot of time in an emergency when time is crucial.

Please place 4" house numbers on your mailbox. Many people have 2" numbers, but they are not as easily seen as 4" ones. Installing larger numbers will help us immensely.

IT'S TIME FOR ANNUAL FIRE INSPECTIONS for all commercial and multiple family dwellings. I'll start doing these inspections this month. Most of you know what to expect, but here's a list of the code requirements and associated fees in case you need a reminder:

- No obstruction of exits.
- Exit sign illumination
- Evacuation and Fire Safety Plans
- Building address numbers displayed
- No extension cords used for permanent wiring
- No open or exposed electrical wiring
- Fire extinguishers maintained
- Fire alarms and Life Safety Systems maintained
- Sprinkler systems maintained

WINTER PARKING ORDINANCE IS NOW IN EFFECT

The Town of Binghamton has a Winter Parking Ordinance that states "No person shall park a vehicle on either side of any town or county highway within the Town of Binghamton between the hours of 11 p.m. and 7 a.m. on each day from December 1 to the following April 1, inclusive.

No owner or operator of a motor vehicle shall park the same unattended on any town street or highway within the Town of Binghamton following any snowfall of two inches


or more until said street or highway shall have been plowed by or at the direction of the Highway Department of the Town of Binghamton. Any two-inch snowfall shall, for the purposes of this section, constitute a snow emergency.

Failure by the operator of a motor vehicle to obey any of the signs erected pursuant to these provisions shall be construed as a violation and punishable upon conviction by a fine." Please abide by this ordinance. It is very difficult for the large snowplows to navigate down narrow streets when cars are parked along the roadways.

I received a phone call this week from a concerned resident who witnessed a large black dog attack and kill a deer. Unfortunately, there is nothing I can do about the incident at this point because the caller was unable to identify the owner of the dog or where the owner lived. It's against the law for a dog to chase and kill a deer. If the incident had been witnessed by a person of authority (DEC, State Police, Sheriff), the dog could have been taken down on the spot. If any of you witness a dog going after a person, a deer, etc., do your best to provide me with the identity of the owner and/or dog so that I can pursue action through the Town Court. Your help is greatly appreciated.





News from County Legislator Kelly Wildoner

As we begin this new year and our community continues working during the current pandemic, I wanted to take a moment to update the residents of the Town of Binghamton with news from the Broome County Legislature.

The Legislature has continued working to protect our community from COVID-19.

Since the beginning of the COVID-19 Pandemic, our County government has continued working around the clock to protect the residents and families of our community. The County recently activated a mobile rapid testing site for COVID, which has been located all around the County for residents to get tested and find out the results in fifteen minutes. The Office of Emergency Services has helped distribute well over 1,000,000 PPE items to schools, local businesses, local healthcare organizations, and frontline workers.
