~AGREEMENT TO SPEND HIGHWAY FUNDS~

~Town of Binghamton~

Pursuant to the provisions of Section 284 of the Highway Law, we agree that the monies levied and collected for the repair and improvement of highways, and received from the state for the repair and improvement of highways, shall be expended as follows:

1. GENERAL REPAIRS: The sum of \$200,000.00 may be expended for general repairs upon 49.52 miles of town highways, including sluices, culverts, and bridges having a span of less than five (5) feet of boardwalks or the renewals thereof.

2. IMPROVEMENTS: The following sums shall be set aside to be expended for the improvement of town highways.

A) On the road commencing at: Moore Ave and leading from East Hamton Rd to West Hamton Rd Intersection. A distance of: 0.21 miles. There shall be expended not over the sum of: \$ 60,000.00 Type: blacktop and milling. Width of traveled surface: 22 ft Thickness: 1.5 inches.

B) On the road commencing at: Morgan Rd (City Line) and leading to Carman Rd a distance of: .71 miles There shall be expended not over the sum of: \$80,000.00 Type: blacktop. Width of traveled surface: 22ft Thickness: 1.5 inches.

C) On the road commencing at: All Other Town Roads and leading to _____ a distance of: _____ miles. There shall be expended not over the sum of: \$ 60,000.00.

This agreement must be signed in duplicate by a majority of the members of the Town Board and by the Town Highway Superintendent.

**TOWN OF BINGHAMTON
LOCAL LAW NO. 6 OF THE YEAR 2013
A LOCAL LAW AMENDING CHAPTER 157
OF THE TOWN OF BINGHAMTON CODE**

Section 1. Chapter 157 of the Town of Binghamton Parks and Recreation Areas shall be amended as follows:

Add new Section 157-__ - Smoking Prohibited.

A. All Town parks, playgrounds, athletic fields and concession stands shall be smoke and tobacco free, with all smoking and tobacco use prohibited in such areas.

B. Notwithstanding the prohibitions of paragraph A above, the parking lots of the Town parks shall be designated smoking areas.

Section 2. This Local Law shall take effect immediately upon filing in the office of the Secretary of State in accordance with section twenty-seven (§27) of the Municipal Home Rule Law.
