A motion was made by Councilperson Nye to adopt a Resolution amending Chapter 157 of the Town of Binghamton Code related to prohibited smoking areas, specifically to include the Community Center, cannabis and vaping, and the motion was duly seconded by Councilperson Bensley. # PUBLIC HEARING: 7:06 p.m. – 25 Powers Rd., Bing., NY – Declare an Unsafe & Dangerous Building

Town Clerk Conklin affirmed that the Notice of Public Hearing had been properly posted and published. The purpose of the Public Hearing is to declare 25 Powers Road, Binghamton, New York an unsafe and dangerous building. Town Attorney Pope advised that this type of proceeding arises out of Chapter 106 for dangerous and unsafe buildings. The property owner was sent an Order and Notice for this evening's public hearing, which was sent by regular and certified mail, and was received and signed for by the owner. The owner was not present for this evening's public hearing. Town Attorney Pope explained the process to the Board as follows: The first step is the Town taking reasonable and immediate steps to ensure that the property is secure. The Town can order the owner to do it. If the owner does not do it within a number of days set by the Town, then the Town would have to secure it with its own forces or by contractor. Those costs can be applied to the property. Apart from securing it, there is some remedial work short of demolition when you hear the proof. If there is proof, the Town would order the owner to take care of those items within a reasonable period of time, and if the owner does not, the Town would do it. Demolition is the ultimate remedial action if nothing is done. The Town has to give the owner a reasonable amount of time to demolish it. If the owner does not demolish it, then the Board would have the right to do it. Town Attorney Pope put the following documents into the record: 1. February 2, 2022 letter by Deputy Town Attorney Rosemarie Pope was sent via regular mail and certified mail, return receipt to Mr. Malik Husain, which involves 25 Powers Road, tax map number no. 161.13-1-43; with that was a Notice and Order that was signed by Deputy Town Attorney Rosemarie Pope involving that same property, which was issued to Mr. Malik Husain as the owner at his address at 6621 Tabor Avenue, Philadelphia, PA 19111. That called for a hearing tonight at 7:02 p.m. so that he was on notice to be here, and the Notice also told him some of the things that the Board would be authorized to do if the Board so votes, which is to secure the premises within five days, demolition removal, and an assessment of expenses. 2. Three different accusatory instruments that were issued by Nick Pappas, the Town's Code Enforcement Officer; all three are dated December 30, 2021; they involve three different code or alleged code violations on this same property. 3. November 4, 2021 Notice of Violation with an Order to Remedy; this went to Mr. Husain at the Philadelphia, PA address involving 25 Powers Road, tax map no. 161.13-1-43, and it listed out the different alleged code violations, including a New York State Fire Code placard removal violation. Mr. Pappas presented the following evidence: It started at the beginning of 2020; it was purchased by a different individual; there were some code issues with a burned down building, garbage all over the property; by the time the owner came into Court, the property had been sold to Malik Husain; once purchased by Mr. Husain, he had a bottom tenant and an upper tenant; the shed was not removed; Mr. Husain did meet with Mr. Pappas and Town Attorney Pope; he did clean up the burned down shed; there is major electrical problems inside the house; the basement is not a habitable space, just sort of hodgepodged together; there is a couple that lives upstairs with a baby; he believes they are still living there; he does not believe there is anybody living in the basement because there is no power in the basement; they have cleaned up the shed; Mr. Husain has missed two Court appearances so far; a trial was held absentia; he has failed to do anything since, consequently the Order of Remedy was issued in December; a couple of months ago there were major garbage issues; the neighbors were dumping the garbage across the street on another property; nothing has been done since this property has been taken over by Mr. Husain. Mr. Pappas does not believe the property needs to be demolished; he does not know how safe it is

upstairs; he placarded the building for all occupants to not occupy, and someone had taken the placard down. At this point, the tenants are still living there. No work has been done; no building permits have been pulled. Mr. Malik had stated that he would remedy everything in two weeks. He has done absolutely nothing with it. Questions were asked and answered. There was discussion. A motion was made by Councilperson Donahue to adopt a Resolution declaring 25 Powers Road, Binghamton, New York 13903 an unsafe and dangerous building; order the owner of the property to give notice to the tenants to be out by April 1, 2022; the building needs to be secured and vacated by April 10, 2022, and the building needs to be code compliant by May 1, 2022, and the motion was duly seconded by Councilperson Bensley. All those present voted in favor of the motion. Motion carried. A roll call vote resulted in the following:

# TOWN OF BINGHAMTON LOCAL LAW NO. 1 OF THE YEAR 2022 A LOCAL LAW AMENDING CHAPTER 157 OF THE TOWN OF BINGHAMTON CODE

Section 1. Chapter 157 of the Town of Binghamton Parks and Recreation Areas shall be amended as follows:

Add amended Section 157 – Smoking Prohibited.

- A. All Town parks, playgrounds, athletic fields, **Community Center** and concession stands shall be smoke, tobacco, **cannabis**, and **vaping** free, with all smoking, tobacco, **cannabis** and **vaping** use prohibited in such areas.
- B. Notwithstanding the prohibitions of paragraph A above, the parking lots of the Town parks shall be designated smoking areas.

Section 2. This Local Law shall take effect immediately upon filing in the office of the Secretary of State in accordance with Section twenty-seven (27) of the Municipal Home Rule Law.
