#### **Planning Board**

- The next meeting will be held on Tuesday, April 25, 2023. Atlas//Binghamton Solar will be in attendance.
- The Mill Street project is still on going,

# **Zoning Board of Appeals**

• There will be a joint meeting with the planning board. There will be a training session at that time.

#### **Youth Commission**

- The next meeting will be held on April 20, 2023.
- The TOB will now have 3 Teener leagues.

#### **Code Enforcement**

- The owner of 25 Powers Road inquired about donating the property to the Town which is not possible. The Town will waive the ordered fine due to the cost of demolition and will give an extension until mid May for the demolition to take place. If the demolition is not done, the fine remains and may be then doubled. There was discussion as to what will happen to the property once the demolition is complete.
- The certified correspondence to 330 Park Ave, was returned back to Code Enforcement. There will be a call for a public hearing on the 18<sup>th</sup> of April,2023 for the 16<sup>th</sup> of May, 2023 for the 330 Park Avenue, and 1978 Montrose Avenue locations.
- The price to install a 20 foot chain link fence at Jackson Park has been estimated at \$1100 \$1200, and is needed.
- Jackson Park: The roof peak near the old Chicken BBQ area needs to be replaced and the picnic tables need to be replaced. Wood tables are priced at \$500.00 just for material to build one table, and powder coated. metal tables have been priced from \$900 \$1200.00
- There was discussion held regarding how many tables should be replaced, and where they would be located in the park.
- The cost of score boards and batting cages was discussed.
- Code Enforcement Officer Soboleski has continued with the CDBG inspections. Some monitoring letters may need to be sent from Town Attorney to various parties regarding code standards that were agreed to at the time of the CDBG contracts.

#### **Highway**

- Roads are being cleaned, stoned and oiled, driveway pipes have been cleaned, dead Ash tree cutbacks have started. Tree canopies are being opened up.
- The fence has been installed at the water tank.

• Broome County had their Public Hearing on March 2<sup>nd</sup>, 2023 for the 10% property tax exemption for Emergency services workers. The Town of Binghamton will have a Public Hearing on the 18<sup>th</sup> of April for the property tax exemption. Discussion was held regarding also having a reduction on school taxes.

#### SUPERVISOR REPORT

• The Town will contact various sources regarding electronics pick up during the scheduled clean up days as the County is not providing this service this season.
