Old Man Winter is finally walking across the floor and is almost out of here, a reference to the 1970 cartoon special "Santa Clause is Comin' to Town." It was another light winter but those are the kind that are hard on the roads. The freeze-thaw cycles and wet conditions are what causes potholes. We will get to your favorite and fill it in. Please feel free to email us at the Highway Department letting us know if you have a particular favorite one. One thing that I am happy I did in my first year is invite residents to reach out to the town if they have a concern or see an issue. I've talked to many of you and have come to know a few. I continue to encourage any Town resident to reach out and let me know of issues. The more eyes on things the better.

Also, a gentle reminder: When you see a road crew, slow down. They're not there just because you're late for an appointment. They're there to make sure the roads are safe for you to pass.

We'll be doing some major road paving in May and chip-sealing in late June. Please check the web page for a complete list as the times grow closer. Also, hydrant flushing will be in May. We'll be performing some preventative maintenance on parts of the water system throughout the Town. Sewer lining is in the cards for the Carman Road area and intellectual (engineering) work is beginning on a project to replace one of the 32-year-old pumps in the Felters Rd pump station. These are just a few projects to expect this spring. Thanks, everyone. We'll talk again in the summer!

TREE BRANCH & BRUSH PICKUP: FRI., APRIL 19 THRU FRI., MAY 17

The Town of Binghamton Highway Dept. will begin picking up branches on Friday, April 19 and will end on Friday, May 17. This pickup is for TREE BRANCHES ONLY. No cuttings from any kind of bush. Due to the overwhelming response to this service, you will not be given a specific day or time when your tree branches will be picked up; simply place your pile at the curb or edge of the road. **CALL ONLY IF YOU HAVE A LARGE PILE THAT NEEDS TO BE APPROVED.** Our number is (607) 669-4323.

There are certain guidelines to be followed:

- Tree branches from your yard only; no cuttings from any kind of bushes.
- Put branches neatly along the curb/roadside in front of your home.
- Please place the large end of the branch towards the road, and leave the branches as long as possible. No piles that look like pickup sticks.
- No brush from clearing your lot.
- No brush from contractors or landscapers. (This means if you hire someone to maintain your lawn, they need to dispose of the debris; we will not take it.)
- Large piles must be approved.

The following items **WILL NOT BE ACCEPTED** and will be left behind: tree trunks; roots of any sort; clippings from lawns, flower beds, or vegetable gardens; thorny brush and small twigs; leaves and animal waste.

A separate dumpster for metal will be available.

ATTENTION: SENIORS TURNING 65 AND OLDER



We want to remind all current participants in the Low-Income Senior Program and those who will be turning 65 in 2025 who may qualify for the Enhanced Star exemption next year to PLEASE KEEP YOUR 2023 TAX RETURN IN A SAFE PLACE. Keep it accessible because eligible residents will need to bring it with them for processing their new Low-Income Senior Exemption and new Enhanced STAR Exemption for 2025.

Also, keep an eye on the mail in the fall as your annual renewal form will be mailed out at that time. Again, you'll be required to bring in your 2023 Income Tax Return for 2025. Having the required tax return will help process your application quickly. Thank you and enjoy the spring!

NOTE: You do not need to renew Enhanced Star.

We will be selling tickets and accepting donations throughout the summer.

In 2023, we secured grant funding through FEMA's "Assistance to Firefighters Grant" and Broome County's "Small Community Fund" grant program which allowed us to purchase a new gear washer and dryer along with a hose dryer. By securing this grant funding, we were able to modify Station 3 (Park Ave.) to create a room where gear and contaminated carcinogenic fire and smoke byproducts can be cleaned. The units at Station 1 were upgraded by adding a hose dryer that doubles as a gear dryer, giving members two places to dry their firefighting gear. The faster a member's gear can get dried, the quicker they can respond to the next call. These important upgrades allow us to clean and maintain our firefighting gear and hose making them safer for our firefighters to use by removing the cancer-causing contaminants while also extending the life of the equipment. We want to thank our County Legislator, Kelly Wildoner, for his help in obtaining some of this funding. Without this funding, these projects would not be possible with the continuously rising costs of doing business. We are always looking for new members. If you would like to join, please stop by our monthly meetings which are on the first Monday of each month at 7 p.m. at the Hawleyton Fire Station. Also, feel free to contact us via email. You can even submit your building permit application via email, if you'd like.

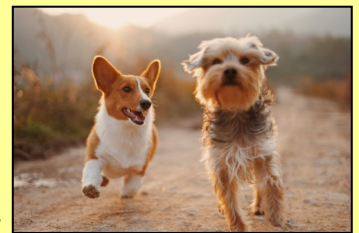
We're assuming you've already read that the Town is holding "Municipal Cleanup Days" again. Some of you have received letters from our office about code violations pertaining to the open storage of junk on your property. This is the perfect opportunity to get rid of your junk for free. We highly encourage all of you to take advantage of this service and to clean up around your property.

Finally, if you accepted financial assistance for the rehab of your home provided under the Community Development Block Grant (CDBG) Program, the receipt of those funds includes a continuing obligation to maintain your property in a neat and clean condition in compliance with all New York State and Town Code requirements. If you have a CDBG grant and allow your property to decline, you'll receive a letter from our office, warning you of the default and a deadline to restore it.

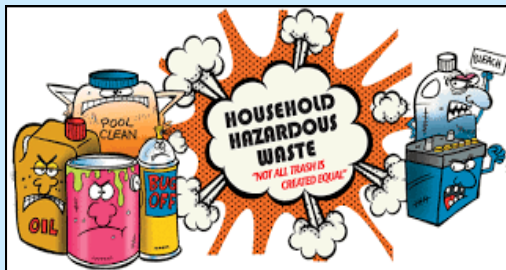

Spring is here, and even our pets know it. They get spring fever, too, and that means they'll soon want to spend even more time outdoors and may get frisky and want to go on a run!

This is a friendly reminder that if I pick up your dog when it's running at large and find that it has no ID and is not licensed, I'll take it to the Broome County Humane Society. In order to retrieve your dog from the shelter, you'll not only have the fees of licensing your dog and getting a rabies vaccination for your dog (if it doesn't have one), you'll also be charged an additional \$50 seizure fee from the Town then another \$50 sheltering fee for sheltering your dog at the Humane Society. If your dog is picked up and taken to the shelter, it could be very costly to redeem it. Please license your dog to avoid the extra fees.

The Broome County Landfill continues to accept hazardous waste (including household and auto batteries, propane tanks, fluorescent bulbs, driveway sealers, paints, solvents, stains, cleaners, pesticides, and pool and photography chemicals) AND old electronics (such as computers, printers, stereos, TVs, copiers, fax machines, mobile phones, etc.) You can drop these off at the landfill on the following days **FREE OF CHARGE** from 7:30 a.m. until 11:30 a.m.:

Weds., June 5 / Sat., June 15 / Weds., July 3 / Sat., July 6

Seventy-one kids in grades 3-6 participated in our basketball programs this season which wrapped up at the end of February. We worked with the coaches at Susquehanna Valley to include our youth in several programs integrated with the school teams such as Youth nights at Varsity games, several Youth Clinics, and Youth Coaches Clinics. This year, we will have 1 Coach-Pitch, 2 Minors & 1 Majors Softball teams, 3 Coach-Pitch, 2 Minors and 3 Majors Baseball teams representing the Town of Binghamton.



Last season, one of our Majors Baseball teams were the Rumble Ponies. We have partnered with the Binghamton Rumble Ponies to help sell some General Admission tickets that can be redeemed for any home game this season. In return, the Rumble Ponies provided official jerseys and hats for the team as well as official Rumble Ponies polos for the coaches. We intend to keep this partnership going this season as well. Once again, our Coach-Pitch, Minors and Majors levels of both softball and baseball will be playing in our Tri-Town League with the Towns of Conklin and Kirkwood. The Town of Windsor Softball program returns to our league again, after joining two seasons ago.

Tee Ball will begin around mid-May in order to ensure good weather and field conditions. With nearly thirty-five players signed up for Tee Ball this year, we will need all the parent volunteers we can get to help run that program.

After a successful inaugural season of Youth Lacrosse, we are looking to expand from K-2 and add a 3rd & 4th Grade Level this season. Our teams play in the Southern Tier Youth Lacrosse League.

News from Our County Legislator Kelly Wildoner

As we make our way into Spring, I wanted to let you know about the progress we're making and the many exciting things happening in Broome County.

Since the start of the new year, the Legislature has been through four sessions, including a special session at the beginning of the year. Our sessions are a major part of the functions of the County. It is a way to make sure departments are spending responsibly, roads are being paved, projects are being completed properly, and more. As the Chair of the County Administration Committee, I help oversee resolutions on local laws, advisory resolutions, rules of order, and the Legislature. Just a quick update on dog license registrations in the Clerk's office. The "Notice of Renewal" will be mailed right around the second week of the month PRIOR to your registration month. A reminder "Notice of Renewal" will be sent out during the second week of your renewal month – this will be considered the second notice. On the last day of the month, if you have not registered your dog, a late and final notice will be mailed to you. Please adhere to the late fee billing schedule that will be included with your second notice. The late fee schedule is as follows:

If the renewal is not paid within 30 days after the initial due date - \$10 late fee

If the renewal is not paid within 60 days after the initial due date - \$20 late fee

If the renewal is not paid within 90 days after the initial due date - \$30 late fee

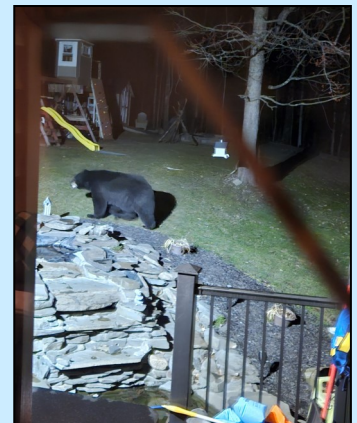
NOTE: These fees are in addition to the standard licensing fee.

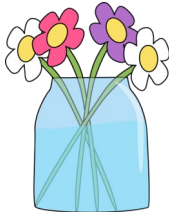
