Pump Station from W20 out of Cortland, NY, the bid was increased to a larger size of pump than requested and it was also brought to our attention that 3 other companies attempted to bid but were unable to do so due to a technical error with the vendors computer. It was suggested that we table the bid received and that we put the Project back out to bid.

NEW BUSINESS:

• Supervisor Rounds has been in contact with Chris Starr from NYCLASS investments. They are an investment company that works strictly with Municipalities. The interest rate for invested money is 5.23% (daily fluctuation). There are no early withdrawal and no zero balance penalties. This gives the Town the option to invest in other areas than just NBT Bank. There is a large list of Municipalities that invest with them and all are collateralized by the Federal home loan bank letter of credit. There was some discussion.

Pursuant to the NYCLASS Municipal cooperation Agreement Amended and Restated as of March 28, 2019;

WHEREAS the Town of Binghamton wishes to satisfy the safety and liquidity needs of their funds;

Now, therefore, it is hereby resolved as follows:

That Elizabeth Rounds, Supervisor of the Town of Binghamton is hereby authorized to participate in the NYCLASS program under the terms of the NYCLASS Municipal Cooperation Agreement Amended and Restated as of March 28, 2019.
