It's fall, and that means **budget time**. The Town Board will be finalizing the budget by the end of this month, and I'm pleased to report that we are on track to reduce the tax rate, once again, for our residents.

The "**Municipal Cleanup Days**" continue to be very successful. We once again offered this service in both May and September. The feedback continues to be overwhelmingly positive. We're happy to know that most of you are taking advantage of this great opportunity to get rid of unwanted junk. As long as the County continues to waive the tipping fees, we'll continue to offer this free service to our residents.

Beginning in January, the **Town Hall business hours will be changing to Tuesdays, Wednesdays, and Thursdays from 9 a.m. to 4 p.m.** Many of our part-time employees are already working that schedule so the change shouldn't have any impact on meeting the needs of our residents. Our full-time employees (two Code Enforcement Officers and the Bookkeeper) will continue to work Monday through Friday and will be available by appointment only.

Finally, the Town is submitting another application for additional CDBG funds in 2025. Read more about it on the bottom of Page 8.

As the seasons march on, I'd like to remind everyone to check the tires on your cars, SUVs, and trucks. Last winter was a slippery one. Many of the assistance calls we received could have been prevented if worn tires had been replaced with new ones. A new set of tires is the best single thing you can do to protect you and your family when the roads become snowy. For more information, go to www.tirerack.com and search for their *W.I.N.T.E.R. Tips* page. There's a lot of good information on YouTube, also. Just search for "Winter Tires".

Another subject I'd like to address is ground water. If you have a sump pump in your home that is pumping out your unwanted water, I'd like to mention that it is against code to drain the water into the sewer line. If that is how you currently have your sump pump set up, please redirect the water to an outside drain that goes to your lawn, garden, etc. Also, when adding drainage around your house or property, please do not direct the water onto the street. This type of situation can cause large ice slicks on the roads in the winter and can quickly become a hazardous situation for everyone.

FALL BRANCH PICKUP IS NOW UNDERWAY. ENDS NOV. 15, 2024

The Town of Binghamton Highway Dept. is currently picking up branches. The last day for pickup will be Friday, November 15, 2024. This pickup is for TREE BRANCHES ONLY. No cuttings from any kind of bush. Due to the overwhelming response to this service, you will not be given a specific time or day when your branches will be picked up. Simply call us with your address, then place your pile at the curb or edge of the road and wait for a pickup. Once snowplowing starts, there will be no branch pickup until the spring thaw.

LARGE PILES NEED TO BE APPROVED BY CALLING US AT (607) 669-4323.

There are certain guidelines to be followed:

1. Tree branches must be from your yard only.
2. Put branches neatly along the curb/roadside in front of your home.
3. Place the large end of the branch towards the road, and leave the branches as long as possible.
4. No brush from clearing your lot.
5. No brush from contractors or landscapers. (This means if you hire someone to maintain your lawn, they need to dispose of the debris; we will not take it.)
6. Large piles must be approved.

The following items will NOT be accepted and will be left behind: tree trunks; roots of any sort; clippings from lawns, flower beds, or vegetable gardens; thorny brush and small twigs; leaves, and animal waste.

FALL LEAF PICKUP: OCTOBER 21 TO NOVEMBER 22, 2024.

Fall is the only time we collect leaves; we don't pick them up in the spring. Here are the details:

- Call the Highway Dept. at 669-4323 to be placed on a list for this service.
- Rake your leaves (with no debris) into a pile in front of your home by the curb line. No pinecones, rocks, branches, flowers, or animal waste can be mixed in with your leaves.
- Do not place leaves in bags!
- Do not rake leaves into your ditch or roadway. This can be very hazardous to traffic.

NOTE: If you hire a landscaper to clean up your leaves, THEY are responsible to take the leaves away. If we see a landscaper raking or blowing leaves from your property to the curb, the Town will NOT remove them. It is the landscaper's responsibility to dispose of them.

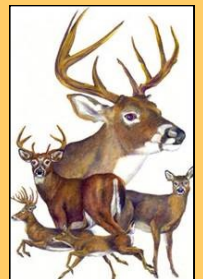

This is a reminder that all exemption applications and renewals must be filed with our office before March 1st each year. We will need your identification and 2023 tax return when filing your application.

2025 Renewal Exemptions – Low Income Seniors and Disability Exemptions

The 2025 renewal exemptions and filing procedures will require income verification. All letters from the Town's Assessor's Office and/or NYS Tax and Finance should be opened, reviewed and returned, if required.

PLEASE NOTE: YOUR AGED EXEMPTION WILL BE BASED ON YOUR 2023 INCOME.

STAR registration for new homeowners

Have you recently moved to a new home in the Town of Binghamton? You may be eligible for the Basic STAR credit which lowers your school taxes. Please visit www.tax.ny.gov/star or call (518) 457-2036.

Enhanced STAR Exemption

The Enhanced STAR Exemption, which also applies only to the school tax, is a special exemption designed for **seniors only**. A senior is defined as a person who is 65, or will be turning 65 anytime during the calendar year. To qualify, you must show proof of income. For the 2025 tax roll year, the **maximum qualifying Federal adjusted gross income is \$107,300**. Your 2023 tax return will be used as documentation when applying in 2025. **You must enroll in Income Verification with NYS.**

Veterans Exemption

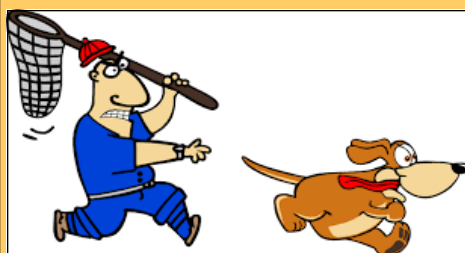
In addition to the Low-Income Senior Citizens Exemption and the Enhanced STAR Exemption, there is also a Veterans Exemption. The Veterans Exemption is available to an honorably discharged Veteran's residence and reduces the Town & County (but not school) taxes. Not only can the Veteran apply, but it is also available to unremarried widows of veterans. Applications are available in our office or on the town's website. A copy of the Veteran's DD214 form must be submitted along with a completed application.

I would like to take a moment to thank everyone who came out and supported the Fire Dept. at our Annual Chicken BBQ. Its success relies on the community support. We also greatly appreciate the Town's support to the Fire Department.

URGENT! PLEASE MAKE SURE YOUR HOUSE NUMBER IS DISPLAYED ON BOTH SIDES OF YOUR MAILBOX AND ON YOUR HOUSE.



We have pleaded with residents over several *Town Talk* publications about your address numbers being visible. This year alone we've had several calls where rescue personnel (Fire, EMS, and Police) have been delayed in getting on scene to provide help because addresses are not visible to responders. **We need ALL residents to take a look at their house and mailboxes to make sure they have their numbers displayed on both sides of the mailbox and on their residence. The minimum height is 4".** We have been asking

Code Enforcement to assist by sending violations to homeowners who are not in compliance with this law. Please keep in mind emergency crews can come from either direction to your property, so it is vital that both sides are visible. Your help is urgently needed.

A REVIEW OF THE WINTER PARKING ORDINANCE



We all know when a storm is coming. If you know a storm is on the way, don't park on the streets because the plows need to be able to navigate down the streets without dodging cars. We do put warnings on windshields but ONE time only. If we receive notification from the Highway Dept. that there's an immediate problem, a ticket will be issued without warning. This is what the Town of Binghamton Winter Parking Ordinance states: "No person shall park a vehicle on either side of any town or county highway

within the Town of Binghamton between the hours of 11 p.m. and 7 a.m. on each day from December 1 to the following April 1, inclusive. No owner or operator of a motor vehicle shall park the same unattended on any town street or highway within the Town of Binghamton following any snowfall of two inches or more until said street or highway shall have been plowed by, or at the direction of, the Highway Department of the Town of Binghamton. Any two-inch snowfall shall, for the purposes of this section, constitute a snow emergency. Failure by the operator of a motor vehicle to obey any of the signs erected pursuant to these provisions shall be construed as a violation and punishable upon conviction by a fine." Please abide by this ordinance.

It is very difficult for the large snowplows to navigate down narrow streets when cars are parked along the roadways. **NOTE FOR PARK TERRACE: NO PARKING ON STREETS AT ANY TIME IN YOUR AREA.**

Test your CO detectors when you're testing your smoke detectors. Every bedroom MUST have a smoke detector and one on each level of your home. For example, if you have three bedrooms on the second floor, you need four smoke detectors (one in each bedroom and one in the hallway) plus a carbon monoxide detector on every level as well. Carbon monoxide is a colorless, odorless, and tasteless gas that is slightly less dense than air. Carbon monoxide poisoning symptoms are often described as "flu-like."

Symptoms include headache, dizziness, weakness, vomiting, chest pain, confusion, etc. If your CO alarm is beeping, DO NOT assume that it's a battery problem. When in doubt, call 911! Also, **have your chimney inspected BEFORE the heating season begins.** A clogged chimney can lead to a chimney fire and/or CO (carbon monoxide) poisoning.

Finally, please make sure your direct-heat vents are cleared from shrubs or other landscaping. The vents need to be free from obstruction. Thanks, and enjoy the fall.

News from County Legislator, Kelly Wildoner

Kelly Wildoner is a County Legislator representing District 3, which includes the Towns of Binghamton and Conklin along with parts of Vestal.

**Updates from Your County Legislator Kelly Wildoner**

As the Broome County Legislature begins the budget process, I wanted to take a moment to update residents in the Town of Binghamton on the various things going on in the County and the Town.

The County Executive delivered his 2025 Budget Address at En-Joie Golf Club in mid-September. It was announced that there would be a **sixth consecutive year of property tax rate cuts**, while maintaining all the critical services in the County. At the 2025 Budget Address, the Executive discussed the need for irrigation improvements at En-Joie, upgrades to County Parks and a lot of other great projects for the coming year. The Legislature began its review of the proposed 2025 budget at the end of September. This time of year is always busy for the Legislature as we have our regular monthly session, budget review meetings, a special session for the budget and more. Our goal is always to maintain critical services, make strategic investments in public safety, infrastructure, parks, economic development and other projects and resources within our community.

Over the past couple of months, there have been a lot of projects that have started construction. One of the bigger projects is the Veterans Resource Center being built on the north side of Binghamton. Construction has begun on the Resource Center, and it is moving along smoothly. It will be great to have a more centralized location for our Veterans and give them easier access to multiple resources. I am excited to see this project finish; our Veterans deserve it.

The Discovery Center has been a community staple for many years and a great place for young families to spend their time. It has continued to expand year after year. This year, my colleagues and I on the Legislature secured funding for a brand-new pirate ship playground. Our kids and families deserve a safe and fun space to spend a nice day. The Discovery Center continues to create a spot to do this, and I am glad we get to support them further. If you want to follow along during our budget process, visit broomecountyny.gov/legis/budget

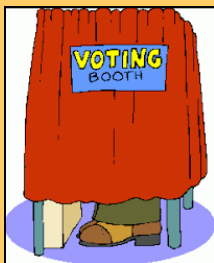
